In the interest of prospective new members and the Club, to be sure new members can be accommodated in line with their aspirations and in accordance with the Club's safe operations, we ask that you read the information below and provide the additional details requested.

The 'reason to be' of Wraysbury Skiff & Punting Club (incorporating Wraysbury Dragons and Waka Ama) is to participate in and support the racing Sports of Skiffing (Traditional rowing), Punting, Dragon Boating and Outrigging. The Club formed almost 100 years ago as a Skiff & Punting Club and has evolved over time, introducing Dragon Boating in the late 1980's and Outrigging around 2020. The Club is primarily a Racing Club and is a registered CASC (Community Amateur Sports Club) run completely by the Membership. The Club welcomes everyone from the community to participate in the Sports offered, all of which involve some intense activity and take place on the River Thames, with its inherent dangers. As such, the Club has Water Safety Guidelines for all disciplines - all prospective members must make themselves familiar with these before their first outing.
